- Regular meeting schedule continues








- 220 patients enrolled

Endo-ERN CPMS panels per country 2024


Sum of Count 1

- 17 meetings (case discussion and tech. support)




CPMS 2.0 - Process






EU Login App: EU Login will phase out SMS as an authentication option




