- It would be great if you come up with suggestions for review papers on your particularly area of interest that we can show that the MTG three is alive and well also in terms of publications. And if you're interested, just contact us and and suggest something and we'll try to figure out how this can be then done.
- Corinne Vigouroux suggested a joint initiative for an European recommendation on diagnosis and management of lipodystrophy -> Pietro Maffei explained that there is a policy to manage this in order to have a guideline or a consensus under the endorsement of the Endo ERN, see Endo-ERN website, contact Perreia!
- Thomas Danne: we should put it on the agenda for our next year's program and make sure that everybody of MTG3 is included who wants to participate
- Julia v. Schnurbein suggested to check with the ECLIP registry to make sure that the work is not done twice. There currently 590 patients in the registry and 17th centuries, so it is quite large, but they would love to include all centers from Europe especially ERN centers. So if anyone is interested in joining ECLIP registry, reach out to Julia, to Corinne or just have a look at the ECLIP webpage.

4. WP4 Healthcare and CPMS

- based on a lot of comments on the difficulty to use the system, the European Commission has built on the second version, CPMS 2.0, and it will be launched soon.
- also if you don't have cases yourself to upload, it's also important to register yourself as an expert.
- MTG three has scheduled a recurring meeting, which is every month, the last Wednesday at 1:30 pm, so the next one is November 29th. Kristina Casteels points out, that Wednesday afternoon is difficult for some centers because of consultations in the afternoon.
